Finally I should mention, just to show a balance from both sides of the Atlantic, perhaps, the Stanley Gibbons web site http://www.stanleygibbons.com/ this would not be new to anyone I am sure but what do you think. I find it very correct in terms of design and layout etc but cold and uninviting. Do you know what I mean? Oh and if you are overseas and want to order a copy of the 2009 Collect GB stamps (list price £9.95) you will be asked to pay £30.00 in postage. Ha ha.

SPAM MAIL

All we recently had a complaint about spam mail being received by one of our members so I thought it appropriate, as a reminder, to tell you about one of the By Laws of our Association.

"BL007.00 By Law: Information Technology, Web and Internet Procedures - (iv) Unacceptable use:

Members must not use the IT for unlawful and/or unethical purposes or harmful to the Association.

Examples of unacceptable use are:-

*sending or forwarding chain mail to or between members,

*transmitting any content that is offensive, harassing, untruthful or fraudulent,

For the purpose of interpreting this By Law, the Board of Directors includes 'spam' as being covered by the words 'chain mail', 'offensive and harassing'." This really is common sense and good manners in many ways but lets remember that the use of spam is now illegal in many parts of the world, or at least considered as extremely unethical.

3C B GRILL

Wish you had one? Even this copy - one of four known apparently and not exactly well centered or with full perfs for that matter, was auctioned October 28th at the Siegel Auction Galleries. An anonymous bidder bid 1.035million US Dollars for the 1868 stamp.

Grill refers to an embossed pattern in the paper; a small pattern (see picture) of indentations intended to discourage postage reuse. They were supposed to work by allowing the ink of the cancellation to be absorbed more readily by the fibers of the stamp paper making it harder to wash off the cancellation ink.





Now, apart from the stamp being rare it has me thinking, here we are, 140 years later, and seeing one postal administration that immediately comes to mind taking steps to stop the reuse of stamps.

Yes, the Royal Mail in the UK with their recent announcement they will be issuing new 1st and 2nd class machins in early 2009 with new security features. Future printings of basic and Large Letter stamps will be printed with iridescent ink in a security pattern in the dark area around the Queen's head, and four small semi-circular slits within the stamp which "will prevent the removal of stamps from envelopes". Ahhh.. No soaking for collectors? Lets see what they are when released.

The stamps will be printed by De La Rue in gravure in self-adhesive sheets of 50 instead of 200 (normal) or 100 (Large) stamps, the first modern definitive stamps to be printed in small sheets suitable for use at PO counters. The change will also affect booklets, business sheets and stamp rolls all of which will be self-adhesive except for the rolls.

The design of the three stamps resembles a three-part alterpiece when shown together.

Been like this for many years I guess now. A humorous style I suppose you could say. All very nice for party games stickers perhaps:-)



These are from drawings by the wife of Allan Ahlberg, associated with his book the Jolly Postman and issued in the year of his 70th birthday — a famous children's author. Something else of interest is that the Isle of Man actually reduced the cost of local mail for the month of December. Now surely a first!





Some members have previously requested that we not use the .bcc address bar because they believe they have not received messages sent by the Secretary to them. Please be reassured that whenever a message is not delivered for some reason, we are advised by the appropriate delivery authority that it could not be delivered. Also, please retain the List of Codes so you can interpret the codes allocated to people named in the list. If you have mislaid yourcode list you can get another from the Secretary.
