## **PAYPAL NEWS**

#### Stamp of the Month

A not sure how clear this comes across but want to show it anyway. Not so much the stamp itself but the MS. Very different form the usual rectangle. This is the shape of a leaf. I thought it was nice. Something I picked up this week form Hong Kong Post.

Anyone want to send me some scans of odd shaped MS. Do your customers collect such things. Sometimes we don't have time to read all the updates we get so I thought I'd run this summary by you, received from the IPDA Secretary. Thanks Alan.

This week I received an email from PayPal which informed me that PayPal has Updated their Policies. On following this up I found that the updates specifically apply to the PayPal User Agreement, the Amendment to the Product Disclosure Statement and these in turn affect the PayPal Sellers and Buyers Policies. The notice of Updated Policies I received apply here in Australia to members residing in Australia. I believe that PayPal may have issued similar Updated Policies in all countries and consequently the updates affect members everywhere.

I believe the individual updated policies need to be studied so that the Board may advise members accordingly and the Board may judge whether the Updates adversely affect doing business through eBay. Will Directors please check whether similar Updates have occurred in their countries. (Editors Note: If members have thoughts to share the Board would be most pleased to hear from you)

As far as Australasia and the Western Pacific is concerned I will study the new policy affecting our members in this region. In the US and Canada perhaps the Chairman would nominate someone to look after that area and for the UK and Western Europe perhaps Roy would look after that area.

I have done a first reading of the Australian policies affected by the updates. I found them to be written in lawyers language and not easy to follow unless done so carefully. Unfortunately, this will affect all of us. The changed policies are important because they deal with all aspects of selling and buying on eBay and touch upon IPDA's rules and policies which we have, for example, refunds, goods not received, dissatisfaction with goods purchased etc. The changes also talk about automatic refunds by PayPal where it thinks a refund is justified; it talks about sellers or buyers not taking legal action until they and PayPal have failed to sort the problem out, and introduces the use of automatic refunds from a member's PayPal account when PayPal believes a refund is entitled; the changed policy also implies that it is no longer worth selling on eBay an item with a value of less than AU\$10.00 because we will have no control over decisions like making refunds.

Catawiki is (apparently) the world's largest online collectables catalogue & marketplace. Catawiki lets you keep track of your collection and wish list, start your own online shop, contact other collectors and, it's completely free! so their advertising goes. Everybody is able to add items to the catalogue and edit them as necessary. Currently, the central database contains over 1,000,000 unique items!

They have been active in the Benelux since 2008 and are now also introducing their concept in the United Kingdom. They say in their promotional materials they are alwayslooking for new and enthusiastic collectors,

## **APRIL 29TH ROYAL WEDDING**

Whether you watched the Royal Wedding of William and Kate or not, or whether you are interested or not, you cannot have missed some of the stamps issues from around the world, whether, you wanted to or not! But did you read about the Niue issue.

The Pacific nation of Niue has been forced to defend issuing "unusual" royal wedding stamps which raised eyebrows around the world by splitting Prince William from his bride-to-be Kate Middleton.

The stamps, approved by Britain's Queen Elizabeth II, have NIUE a perforated line between the royal couple. Together they

are worth NZ\$5.80 (£2.70) but when separated Prince William is worth \$3.40 and Kate Middleton a cheaper \$2.40.



Toke Talagi, the Niue premier, said he had received plenty of feedback from around the world since the stamps were issued last month with people saying they found them "unusual".

"People indicated the stamps, made by New Zealand Post, meant the couple will separate in future. I don't know why they would interpret it that way," he said. "I don't think it means that. I think it means we're very happy celebrating the royal marriage."

However, Mr Talagi said the stamps could be a tourism boost for the country, which occupies a 100-square-mile coral island in the south Pacific and has a population of just 1,400.
