Poppe Stamps Philippines, Inc. - Philippe & Guido Poppe



Over the past few years I have had the pleasure of visiting a few of our members and have followed those visits with articles on them, their business and their interests. In the following I am very pleased to write up my recent meeting with Philippe Poppe (above) and tell you about my trip to The Philippines to meet him. I should add I first met Philippe in Hong Kong some 18 or so months back over a very enjoyable dinner. This time, I finally managed to get to Cebu and meet him at his office and, fortunately for me over dinner later that day, with his father and family.

Before I start, let me set the scene for this visit. I have had a long standing invitation to visit Cebu and when I finally made my travel plans I was pretty excited to be honest. Due to depart Hong Kong Friday 8th November. Sadly though, as I guess you must know from reading the news, the typhoon Yolanda hit that very day. Three times the force of Hurricane Katrina and such that my flight was delayed 20 hours. No problem for me but so sad for all the families in the Philippines as you will surely know. Fortunately Mactan, where Philippe lives in Cebu, while badly hit was not closed down and did not suffer the severe damage that some other parts of Cebu did. Added to this situation was the fact that only six week prior, the area had also been affected by a pretty significant earthquake. All this to set the scene since I saw the impact of both, the earthquake and the typhoon.

Philippe and his father Guido run Poppe stamps (have a look at a great website) from a really stunning office in Mac-

tan Cebu. On arrival at Cebu, Philippe and his wife met us at the airport and drove us to their office.

Set in a modern and sprawling industrial park they have 1000 sq ft of space. A sizeable operation but not all for stamps as you will read later.

The tour started in the main office area. See picture to right. A spacious set up with state of the art computers and work spaces and a library to dream off, both for stamp catalogues and books on <u>conchology</u>. Do visit their website.

Yes conchology is their other business and it was this aspect of the office and storage that Impressed me even more than the philatelic side..

We toured other rooms and to be honest it was like visiting a museum with beautiful shell displays. Many rare and all so beautiful.

In addition we saw display cases of model ships all made by Philippe. Stunning models.

Every now and them Philippe would point out some slight damage to a ship or a shell. The reason being the earthquake as I mentioned early.


Some walls of the office also had cracks in them but generally the building was sound and the damage, fortunately, was minimal.

Then to the stamps. Philippe has over 2 million stamp lots listed on his website. How do you store that quantity. In fact how do you catalogue and scan that number?

With wonderful staff, efficient systems, top of the line computers and peripherals, and an organisation that is brilliantly managed. The picture perhaps gives a perspective of the filing cabinets. A very, very long line of drawers packed with all of those 2 million stamps, all very clearly catalogued.

Later that evening we joined Philippe, his wife and his father and partner for a wonderful dinner at the Shangri La Hotel. What excellent company, interesting conversation, excellent food and great service from the hotel staff, who were serving us in a private dining room. I cannot write about what we discussed. Lots of talk of stamps and stamp dealers and the stamp market, pricing, marketing opportunities, sales numbers, quality, collecting interest, IPDA member participation, etc etc, but, as I am sure you understand, what plays in Las Vegas, stays in Las Vegas. or should I say, in the Shangri La in Cebu!!

Sadly we did not take a picture of us all at dinner. So busy chatting we just didn't think of it, so I show one of Philippe

Although our trip to Cebu was short we still managed to do a few hours of sightseeing on the Sunday before the flight back to Hong Kong. I mentioned the typhoon earlier and I must admit that while some of the damage was pretty severe it was insignificant compared to what had happened in Tacloban and other parts of northern Cebu.

A few pictures which I would like to share with you.

There is a fair amount of interesting history and architecture there in Cebu City as the Spanish were there from around the early 1500's and left their mark so to speak.



This tree fell away from the Cross of Magellan — so fortunate that this was not destroyed.

Magellan's Cross is a Christian cross planted by Portuguese, and Spanish explorers as ordered by Ferdinand Magellan upon arriving in Cebu in the Philippines on April 21, 1521



The frames around the arches were erected before the typhoon to protect it



This is Fort san Pedro — Fuerza de San Pedro is a military defence structure, built by Spanish and indigenous Cebuano labourers under the command of Spanish conquistador, Miguel López de Legazpi and the Spanish Government in Cebu in 1738 I believe, although a plaque on the entrance shows the date 1539




And to finish, I could have stayed on the beach forever!!! It was so lovely, the sun was just so warm and the water so inviting.

CANADA 1851 12D STAMP TOPS SIEGEL AUCTION

I have written twice now on rare Canada stamps and here again is another. Something I read during the week. I must look at my old stock. I can dream can't I.

A good example of the Canada 1851 12d black has seen the highest bids in Robert A Siegel Auction Galleries' Worldwide Stamps and Postal History sale, held on November 13-14 in New York.

The stamp is a used example, bearing a target cancel with four full to large margins, a small repair and other faults. Despite the defects, it made \$32,500, having not appeared on the market since 1963.



Get Involved in the Internet Sales Tax Debate

SEND A LETTER -



If the Marketplace Fairness Act is allowed to become law, it could require small, internet-enabled businesses to collect sales taxes nationwide from the more than 9,600 tax jurisdictions. These same small businesses could face the prospect of being audited by tax collectors from other states. On behalf of our eBay Inc. community, we are pushing Congress to include meaningful protections for small businesses.

The good news is that hundreds of thousands of consumers and small business owners have contacted Capitol Hill to express their concerns. Despite this positive development, the bill's supporters and their Washington lobbyists still want to get the bill through Congress by attaching it to important pieces of legislation that Congress must pass, such as a federal budget bill. Congress must fix the Senate bill by significantly increasing the small business exemption. That is why we need your help.

If you oppose attempts to force an unfair Internet sales tax bill into law, <u>raise your voice</u> and let your representatives in Congress know.

LETTERS TO THE EDITOR - UK POSTAL CHARGES

A new applicant was recently criticised by a member as he felt his postal charges were on the high side, quoting two pounds to send an order from UK to North America. I immediately came to the applicant's defense as my postal charges are actually higher than this at two pounds fifty (\$4.00 US). This has prompted me to write the following.

I am a thematic dealer and my stock includes large sheetlets, artworks, covers and presentation packs apart from individual sets and singles. These largish items determined that I should rationalize and try to use a uniform envelope size and C4 and C5 seemed to fit the bill.

I have a website but many of my sales come from eBay, Delcampe, BidStart and Specialist Auction and to promote my site, I had cards printed displaying my web address - these cards serve admirably as an envelope stiffener. So my average order will go out with a C5 envelope, a stiffener card, an invoice (which I regard as essential if you're professional) plus of course the ordered stamps. To keep my customers happy I always use Commemorative stamps for postage and these in themselves can weigh several grams. The bottom line is a postal packet which usually exceeds 40g in weight for which the Royal Mail charge is 2.48 GBP (\$3.97). If the packet exceeds 60g then its 3.08 GBP (\$4.93) and if its over 80g then it's a massive 3.50 GBP (\$5.60). If the contents have a value above 100 pounds then my insurers insist I send it registered so the minimum charge now becomes 7.50 GBP (\$12.00).

UK addresses aren't quite so expensive but here we have the added problem of thickness. Royal Mail regard anything thicker than 5mm as 'large' for which they charge a premium. My C5 envelope, card, invoice and stamps are borderline but I dare not use the lower rate for fear my customer would be hit with a surcharge which works out to the difference in charge plus a one pound fee. So I charge my UK customers 95p which just covers the Royal Mail current charge of 90p.

I know postal costs are a big issue with some people – but not all! My website requires a minimum order which is tacked on to the postage fee until that minimum is reached. Nevertheless, I occasionally get orders for a cheap item (say one pound) but the customer seems guite happy to pay the minimum price of 7.50 GBP.
