#### Spitfire Women by Roger West, Director UK and Europe

I recently saw a television programme called 'Spitfire Women'. It was about the brave women pilots who in World War 2 flew aircraft from the factories to the airfields where they were required. These women formed the ATA (Air Transport Authority). Of particular interest to me was the name of Lettice Curtis who was a fellow member of the Wokingham Philatelic Society - Lettice had a passion for the GB KG5 1.5d brown.





The ATA was set up at a time when pilots were in very short supply. 164 women with flying experience were invited to join and became known to their male counterparts as 'atagirls'. Several of these girls acquired fame such as Maureen Dunlop who was a cover girl for Picture Post, Helen Kerly who received a commendation, Amy Johnson, already a household name for her solo flight from Britain to Australia and Lettice Curtis.

Lettice got her name in the record books by becoming the first woman to fly solo in a four-engined aircraft - the Halifax. During her ATA term, she made nearly 1,500 flights in dozens of different aircraft including The Stirling, Lancasters, Liberators, a B-17 Flying Fortress and of course, the Spitfire.

When the war ended, Lettice was still a flyer and in 1992 aged 77 she achieved her Helicopter Pilot's Licence, the oldest British women to do so. Lettice passed away in 2014 aged 99 years. She was, a remarkable women and whenever I see the humble KG5 1.5d brown I think of Lettice.

#### **Illegal Stamps**

The following is based on material from member Peter de Jong, who wrote to the Newsletter saying he came into contact with IPDA member John Lowe and was impressed by John's research on illegal stamps and felt something should be written on this topic.

Everyone is free to collect what they want. There is no argument to that. However, it is fraudulent to produce and knowingly sell illegal stamps when the material presented is not correctly described. I thought it worth showing some examples for information purposes.

According to the UPU, "an illegal stamp is one that carries the name of a legitimate country or territory but was not

Why would anyone want a stamp, let alone a Miniature Sheet of stamps, showing Ben Aflfeck?

The majority of illegal stamps on the market today are modern topical issues. The images show some examples for readers understanding. The major production of these started to be seen in the mid 90's. This material is commonly found on eBay, Delcampe, eBid, Amazon and so forth, even though the UPU has posted many circulars denouncing them. The UPU circulars describe many of the issues but their policy has been, until now, not to post images of the illegals.

#### **Describing stamps for sale**

The following is from member Michael Dodd. Michael is also the IPDA General Secretary. One of his passions about stamp selling is the accurate description of the stamps being offered for sale. The following show some recent examples he has seen and believes worthy of comment to remind all members what we, as IPDA members, should and should not aspire to.

I have written on this topic frequently over the years, in IPDA Newsletters, on my Blogs and on my Website. If there is one thing about selling stamps that I am passionate about more than anything else it is the correct description of the stamps being offered by sale. I am not going to comment on the price other than to give it for context.

As a Director of the IPDA I am asked to review new member applications. Over the past three months we have had over 50 new member applications. How refreshing it has been to see very high standards from the dealers we have seen apply. I have not seen one application where I could question the quality description of the stamps being offered for sale, or in fact the actual quality of the stamps themselves.

Of course, this is not always the case. As dealers, whether we be full time or part time, we are faced with incredible competition in this internet day and age. This competition comes from so many sellers who have, in my opinion, no experience, knowledge or respect for collectors in this wonderful hobby.



I was motivated to write this because I saw this stamp offered for sale. I could have chosen any one of hundreds of different stamps I might add, but this is a stamp we would all like in our collections if we collect GB, and lets face it, it does stand out, doesn't it! It is of course Scott 124 (SG 212) the 1891 issue. Guess the price before you read on. Ok, it was being offered at \$724 USD with free shipping and described as Used. That is it, Used.



Described as Used Very Fine with no faults or imperfections on the gum side at \$495 USD with shipping of \$15.



Described as Used and offered at \$325 USD also with Free Shipping.



Described as Used and offered at \$350 plus \$3.85 shipping.

I leave you to draw your own conclusions. Lets make sure we uphold the standards we all aspire to as members of the IPDA. You might say, well a collector would never consider buying the first example, but then again how could a seller ever consider pricing it at USD \$724? Let's just say they are not an IPDA member, and, to date, one of the others is
