I am confident that there has to be a few specialists in our group. Please feel free to post on our social media pages.





#### Knowing how to find the Forgery

After a long week I grabbed my coffee and tablet. Off to my favorite source of Persian stamps, Hipstamp.com After 20 pages of seeing the same stamps listed I stopped scanning and wrote this article. If we are collectors and sellers of history (stamps), then it is time to root out the fakes. Fake stamps: Steal your money. Ruin the hobby and Wastes everyone's time.



No matter what country you collect or sell, there is always the possibility of fake stamps offered for sale. With Persia, my area of specialty, you have to know your material, period. If not, the snake oil salesmen will get rich off you and continue to sell junk, as I call it. Seen left is a commonly offered set of stamps that have a high catalogue value in Mint Never Hinged condition. These are pure junk.

I have said this many times before, if you don't see a postmark on any stamp from any country and it's being offered at \$50.00 or more, think snake oil salesman. Sadly, this seller can't even count correctly. The stamps should be in numerical order. i.e-1, 3, 5, 6 and 12. Look closely. This seller's stamp starts at 5, then 1 and so on. I think the driving factor in 'selling' these fakes are the values seen in the catalogues. This set has a total catalogue of \$185.00usd. You can see why the snake oil salesman lined these up to sell. Here is a tip for you. Always look for the double lines over the letter 'P' on the left side.

Can you see the two lines over the letter 'P'? There you go, you are now an expert in snake oil salesmen offerings on hipstamp.com.

Let's all join together and root these sellers off of hipstamp.com

Philatelic exhibiting represents many challenges to the most experienced of philatelists and postal historians.

There are many formal judging criteria that the exhibitor must satisfy.

For the novice exhibitor, however, the criterion of "importance" offers a particular set of challenges.

In this writing and the accompanying Table Gary explains the subject of importance by developing a taxonomy of philatelic importance.

An auction in July now from member Andrew McGavin of UPA Universal Philatelic Auctions. They have their UPA82 auction which





### Why Collectors need IPDA members: reason 1469

A colleague in the USA wrote to me recently. This is 100% as he wrote. No embellishment on my part. He runs a very small stamp business, low sales volume and also he is a collector who has a rather impressive collection and web site displaying his material for the enjoyment of others.

His email was our typical daily chit chat and the fact he was trying to improve his UPU collection. And this.




He saw this listing and asked the seller for a scan of all the stamps. He was thinking a useful set for the price. This is the reply he got. "the set is under \$2 so I do not have the time to show you the entire set before you purchase it"

Seriously, are sellers like this damaging the hobby? Of course they are. I could write pages on this particular seller but I wont. You all know why we need IPDA members to promote IPDA values and ethics and respect for stamp collectors. Just a few comments though. Read the listing for yourself. Is this taking advantage of the less experienced buyer?

It saddens me, it really does. The image is just a "stock photo". Yet the listing says two are offered for sale. And, although the reply from the seller clearly states they do not have time to list all 4 stamps. What exactly is for sale one wonders? Is it really just SG 165 and SG 166? Let us assume it is. Described as VFU. From a stock photo how would you know? And the Quantity? Yes 2. So what exactly would you get if you were to buy? And the price for 2 stamps you cannot see before you buy is 60% of SG 2021 catalogue value, (or using Scott 2017 my most recent edition the cat is \$1.20 — that is they are selling at 165% of Scott for genuine VFU) Buyer beware all right! Oh, and for your amusement just one more point. The seller has this listing and another listing for the 4 stamps in the issue, and both with the same "stock" image. Are they a credible seller or what!

So there you have it. **Together we can**..... Work together to promote the IPDA brand, IPDA member credentials to collectors so collectors can start ignoring these types of sellers and NEVER buy from them again, but buy from accredited and quality IPDA members. **Only you as members can make it happen.** 



#### Letters to the Editor

A few replies to the comments in the May issue. Here are some of the points made. It is interesting to see some sales increase successes and perhaps rather negative views on eBay. Obviously not a statistically representative sample of responses so if you have views you would like to share, perhaps because you think they will be helpful to other members please do drop me an email at cddstamps@gmail.com

I am selling on 5 sites. eBay, Delcampe, Hipstamp, Webstore and eBid, with a total of 10,000+ listings. 18 year seller — Last year my sales increased 75 %. I have inside connection to some of the bigger auctions houses (European) and have been told sales are rocketing, and prices also.

eBay still the best site for me, Hipstamp are starting to move up. I have been with Delcampe for around 15+ years. Delcampe 3-5 sales per month. Sales on Delcampe is going down year after year. Webstore and eBid 2-3 sales per. year.

People I have been in contact with and not had interest in collecting for many years, have found their old dusty albums, and are very exited and happy to be starting up collecting again. Overall, I am very optimistic for the future of stamp collecting.

**Comments on Hipstamp:** I read the forum and I have not notice unacceptable behaviour that I have taken notice of. I expect sales from Hipstamp will still increase for me.

**Comments on eBay:** The new eBay managed payment and increasing control of sellers business, will in my opinion result in many sellers and buyers leaving eBay, and move business to other sites, or build own website. Another member commented they have closed all listings on eBay.

One interesting aspect to eBay feedback regarding shipping: A member commented that - I have almost 6000 all positive feedbacks. My top rating are starting to move down. Due to customers rating of post transit time. (Delay ). My informed shipping is listings shipped in 2 days, but I ship same day or next day. When customer receives the order and are giving feedback stars as for shipping time and order has been delayed in the post system in some cases the buyer give low rating, example 1 star.

This has resulted in eBay giving me a defect rating and it adds up in a negative way on my account. The wording eBay is placing on sellers defect form is **"Transactions that weren't shipped on time**:" In this covid day and age shipping is taking longer and customers are often not accepting this as not being a sellers delay at all.

#### Stamps from country Letter S



Let's start at the end this time. Do you know where this country is? Or what it was called before Independence?

This kingdom gained independence in 1968. although it was only in 2018 that it started to issue stamps inscribed "Eswatini".

What about if I mention the beginning?

The first stamps of this kingdom were overprinted stamps of the South African Republic (Transvaal) and were issued in 1889

Yes it was Swaziland. Swaziland became a protectorate of the South African Republic in 1894 and the stamps of the South African Republic were used.

In 1902, Swaziland became a British protectorate following the Second Boer War and the stamps of the Transvaal Colony were used. From 1910, the stamps of the Union of South Africa were used. Stamps were issued for Swaziland again in 1933 and from then through to QE II with the regular British Commonwealth commemorative issues and some stunning QE II definitive issues through to the 1967 Protected State issues.





It is planned and it is happening. So says the APS web site and it seem the response from collectors, exhibitors, societies, and dealers who made commitments to attend the show has been a major factor in this achievement to date. Well done the APS.
